5. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of Twenty-Five Thousand Pesos (**Php 25,000.00**).

CASURECO 1 will hold the face to face Pre-Bid Conference and the Opening of Bid (date and time stated above) at Rm. 303 Hall of P's, CASURECO 1 Main Office, which will be open only to all interested parties who have purchased bidding documents and Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below.


